Primary Photo Report Clothes Drying

ACTION TAKEN:

On December 15, 2012 at approximately 1751 hours Det. Sliby took into custody the clothing of victims from Det. Greenstein, as collected as evidence by him from OCME, and transported to the Western District Crime Van located in Newtown.

After the clothing was collected and inventoried from Det. Greenstein, the clothing was staged in the heated temporary morgue, which had been converted into a massive drying tent for the heavily soiled clothing. Temporary clothes lines were fastened to the interior of the tent and each was marked with an evidence marker so designated by evidence officer Det. Sliby. These items were each crossed referenced against the OCME issued number, where positive identification had been made by that office. The clothing was unfurled and hung with heavily soiled sections nearest to the floor, on either a solo line, or a line that was specifically designated by evidence markers to dry two victims clothing. The clothing was fastened by CSP Tpr. Kenneth Dillon, Agent Lisa Skelly Byrnes, and Agent Samuel DiPasquale of the CT division of the FBI. This was done under my direction while I memorialized each victim's respective clothing, exhibit number, and OCME corresponding number. These notes were provided to Det. Sliby to assist in his evidence report. See his detailed report.

Because of atmospheric conditions and technical problems with the tent heater, it took several days for the clothing to

thoroughly dry so as they could be properly photographed and packaged for long term evidentiary storage.

The photographs were taken with a Nikon Digital SLR D300s Programmable camera with detachable Nikon SB-910 speed light flash. A compact flash card was utilized to store the images until they were burned onto compact disk. A disk was made and forwarded to the State Police Forensic Lab for permanent archival, as they remain the central repository for all CSP photographic evidence.

The CD containing eight (8) photographs has merely memorialized the drying process. A two day painstaking and thorough processing was undertaken by van detectives upon the completion of the drying process to memorialize evidence of or upon the clothing of victims. See Det.
