PRIMARY PHOTO REPORT SPECIAL AGENT SKELLY BYRNES CELL PHONE

ACTION TAKEN:

On December 14, 2012 at approximately 12:00 noon Special Agent Lisa Skelly Byrnes, assigned as a liaison from the FBI to the Western District Major Crimes Van Unit, stated that the FBI had agents on sight with the brother of Adam Lanza in New Jersey, and were in immediate need of a photo of the deceased suspect shooter. Further, the FBI specialist in firearms required a photograph of the weapons to begin the process of positively identifying the types and configurations of each weapon.

The van squad had not begun the process of photographing the scene, and the most expedient method of transmitting the photos was determined to be the cell phone of Special Agent Skelly Byrnes. After donning appropriate PPE, SA Skelly Byrnes and I took several photographs with her cell phone device. SA Skelly Byrnes in turn transmitted the photos to the respective agents requiring them, as well as my government assigned email, Jeffrey.covello@ct.gov, so as a report could be generated by me to account for these photos having been taken and transmitted at the onset of this investigation. After the photos had been transmitted to each respective location, she personally communicated to me that she had permanently erased the photographs from her cell phone device.

Attached to this report are copies of both the respective emails and photo attachments, as well as the printed photos.

Photo No. 1 Depicts the .223 Bushmaster rifle.

Photo No. 2 Depicts a close-up of the suspect shooter's face (later identified as Adam Lanza).

Photo No. 3 Depicts an even closer view of the suspect shooters face.

Photo No. 4 Depicts the 9mm Sig-Sauer pistol in the suspects left front pant pocket.

Photo No. 5 Depicts an overall of the suspect shooter.

Photo No. 6 Depicts a view of the 10mm Glock pistol found near body of suspect shooter.

NOTE: The accompanying CD has seven (7) photographs, v. six (6) listed above, one of which is an enhanced double for a more detailed view of the shooters face. These were taken to assist in discerning the Lanza brothers apart, as well as identifying what types of weapons were in possession of shooter and where they may have originated. The photographs are not necessarily arranged in any specific order nor as they were taken, and NO positive ID was possible or accomplished.

I made an additional CD from the same seven (7) images which has been forwarded to the Department of Emergency Services and Public Protection Forensic Lab Division, who remains the central repository for all photographic evidence archived by the State Police.
