ACTION TAKEN:

On December 15, 2012 TFC. Carlo Guerra presented a personnel cell phone device to me with six (6) extremely graphic photographs of Sgt. William Cario inside the Sandy Hook Elementary School amongst numerous child bodies and two adult bodies pilled inside and around a closet size classroom toilet. TFC. Guerra explained that the photos were taken under the direction of Sgt. Cario, who wanted him to document scene prior to his disturbing it to locate potential, however unlikely, survivors. See TFC. Guerra's detailed report.

I downloaded six (6) cellular phone photographs from TFC. Guerra's phone to my assigned department laptop, and then transfered the images to the WDMC van computer (no CD drive on department laptop) so they could be then burned to CD. The CD was then seized by evidence officer Det. Sliby. See Det. Sliby's detailed report.

I made an additional CD from the same six (6) images which has been forwarded to the Department of Emergency Services and Public Protection Forensic Lab Division, who remains the central repository for all photographic evidence archived by the State Police.
