ACTION TAKEN:

On 12/16/12 at approximately 1100 hours, I was assigned to respond to Sandy Hook Elementary School to meet with members of the Major Crime Van to pick up evidence to be transported to the E.O.C. located on Mile Hill South Rd. At approximately 1230 hours, I received a cell phone(exhibit #27) belonging to Adam Lanza from Det. Sliby #810. At approximately 1258 hours, I received two identical CDs containing images of the Izhmash shotgun that was seized from Lanza's vehicle. The cell phone and the two CDs were transported to the E.O.C. At 1506 hours, I turned the two CDs over to Lt. Baldwin at the E.O.C. At approximately 1630 hours, I turned the cell phone (exhibit #27) over to Detective Grandpre to be transported to the State Police Computer Crime and Electronic Evidence Laboratory in Meriden, CT to be downloaded.
