Action Taken: On 2/12/13 at approximately 1941 hours, this Detective met with Detective Rupsis #1260, who turned over possession of Exhibits #55 through #77. This Detective signed the respective JD-CR-18's for the aforementioned exhibits, indicating that Detective Rupsis had relinquished custody of the Exhibits to this Detective.

On 2/12/13, between 2000 and 0331 hours, this Detective, Detective Jewiss #336, Sgt. Covello #167, Detective Sliby #810 and Detective Rupsis #1260, in addition to personnel from a commercial dry cleaner located in Torrington, CT, treated, processed and laundered the clothing and property belonging to the deceased victims from the Sandy Hook Elementary School shooting. Upon completion of the laundering, the clean clothing and property from each victim was individually repackaged and re labeled as evidence for return to Troop A. In preparation for the point in time when some of the clothing and property will be returned to the victim's families, a new JD-CR-18 for each Exhibit # was prepared by Detective Jewiss.


On 2/12/13, between 0331 and 0420 hours, the aforementioned Exhibits were transported by #336 back to Troop A, 90 Lakeside Road, Southbury, CT. Upon arrival at Troop A at approximately 0420 hours, this Detective and Detective Jewiss removed the Exhibits from his vehicle and secured them in temporary evidence storage in the female locker room located on the lower floor of the barracks, where the items had the opportunity to continue to air-dry to remove any remaining dampness.

On 2/12/13, at approximately 0455 hours, the temporary evidence area within the locker room was sectioned off secured using evidence tape and the door to the locker room was double key locked by this Detective.
