ACTION TAKEN: On 12/18/2012 at approximately 1130 hours, I was instructed by the Command Post dispatcher to respond to the Sandy Hook Elementary School scene and make contact with Sergeant Jeffery Covello, #167 regarding the return of property. Upon my arrival I met and received detailed instructions from Sgt Covello regarding the return of personal property removed from the body of Mary Sherlach by members of the Office of the Chief Medical Examiner. Sgt Covello further instructed me to return the property to the Sherlach family and obtain a signed receipt. Sgt. Covello then handed me an envelope containing six items including: Eye glasses, a ring, a ring with stone, a ring with white/purple stone, a ring with colored stones, and a watch. I departed the Major Crime scene and telephoned **104 104 104** to advise of my effort to return property to **104** 

in a quiet room of the house. After a brief explanation of the purpose to return personal property of Mary Sherlach to

the family, I handed the envelope to 04 and departed the room. At 1555 hours, 10004 met with me in the kitchen and handed me a signed receipt for the six items. After spending the next few hours with the family, I departed and returned the receipt to Sgt Covello at the Major Crime scene. This assignment is complete. No further action.
