**VICTIM IDENTIFICATION
DIGITAL PHOTOGRAPHY REPORT**

On Friday December 14, 2012, the Connecticut State Police Central District Major Crime Squad (CDMCS) was assigned to assist with a Homicide Investigation at the Sandy Hook Elementary School, located at 12 Dickenson Drive, Newtown, Connecticut. The incident involved a suspect Adam Lanza (DOB 04/22/1982) who entered the school, shot and killed numerous victims then died of a self inflicted gunshot wound. CDMCS investigators were assigned to assist with the identification of the victims.

The following color photographs #1-28 were taken by this investigator to depict the victim with their assigned OCME case number. The photographs were taken in the event that they may be needed to assist with positive identification of victims. The photographs were taken utilizing the unit's assigned NIKON D300 digital programmable camera. The built in flash and/or artificial lighting was utilized when necessary. The images were stored on a digital media card. The images were transferred to a CD and printed by the Connecticut State Police Forensic Laboratory. The digital media card was reformatted for future use and no longer contains the images captured at this incident.
