VICTIM POSTMORTEM EXAMINATION DIGITAL PHOTOGRAPHY REPORT

On Friday December 14, 2012, the Connecticut State Police Central District Major Crime Squad (CDMCS) was assigned to assist with a Homicide Investigation at the Sandy Hook Elementary School, located at 12 Dickenson Drive, Newtown, Connecticut. The incident involved a suspect Adam Lanza (DOB 04/22/1982) who entered the school, shot and killed numerous victims then died of a self inflicted gunshot wound. CDMCS investigators were assigned to attend the postmortem examination of the victims on Saturday December 15, 2012. The postmortem examinations were conducted at the Office of the Chief Medical Examiner, located at 11 Shuttle Road, Farmington, Connecticut.

The following color photographs #1-50 were taken by this investigator prior to the start of the postmortem examination of the victims. The photographs were taken to depict the victim with their assigned OCME case number. The photographs were taken utilizing the unit's assigned NIKON D300 digital programmable camera. The built in flash and/or artificial lighting was utilized when necessary. The images were stored on a digital media card. The images were transferred to a CD and printed by the Connecticut State Police Forensic Laboratory. The digital media card was reformatted for future use and no longer contains the images captured at this incident.
