Medical Examiner Supplemental Report

Date and Time of Investigation:

December 15, 2012 through December 16, 2012.

Summary of Incident:

On December 14, 2012 at approximately 0935 hours, the Newtown Police Department and the Connecticut State Police responded to an active shooter situation at Sandy Hook Elementary School located at 12 Dickinson Drive in Newtown, Connecticut. The incident involved the suspect, Adam Lanza (DOB 04/22/82), who entered the school, shot and murdered numerous victims, which ultimately ended with Adam Lanza dying of a self inflicted gunshot wound.

Action Taken:

On December 15, 2012, I attended the post mortem examinations for the victims of the above mentioned incident. Several items of evidentiary value were seized from the victims while they were located at the Office of the Chief Medical Examiner (OCME) in Farmington, Connecticut. I transferred those items from the OCME, via my assigned department vehicle (416WHK), to the scene. I arrived on scene and transferred the items of evidence to Det. Silby (WDMC) at approximately 1751 hours. It should be noted that at the conclusion of the autopsies, the OCME turned over bullet fragments (Exhibit #125) they had recovered and indicated that they did not correspond with any one specific victim.

On December 16, 2012, I attended the post mortem examination for the suspect (Adam Lanza). Several items of evidentiary value were seized from the suspect while he was located at the OCME. I transferred those items from the OCME, via my assigned department vehicle (416WHK), to the scene. I arrived on scene and then transferred the items of evidence to TFC Keith Asman (Troop L Evidence Officer) at approximately 1534 hours.
