CRIME SCENE LOGS

(Sandy Hook Elementary School)

ACTION TAKEN: On Thursday, December 20th, 2012, prior to securing from the Sandy Hook Elementary School at the completion of processing this school shooting incident, I observed several sheets of paper on a table in the lobby of the school. I observed these sheets of paper to contain handwritten material of names, dates and times, consistent with a crime scene log. I collected these sheets of paper and maintained them until Thursday, April 25th, 2013 when I turned them over to Troop A Major Crime Sgt. Josh Pattberg #130.

This crime scene log appears to begin on December 14, 2012 at approximately 1045 hours with a list of Newtown Police Officers on scene and documents CSP-Lieutenant David DelVecchia at 1059 hours. It is unclear from these documents who begins this log and holds this post. On December 14, 2012 TFC. Thomas Fabian #1100 takes over the task of the log and post at 1705 hours. TFC. Eagleston takes over the talk of the log and post at 2130 hours. TFC. Abbey #1314 takes over the log and this post on December 15, 2012 at approximately 0800 hours. The log appears to conclude on December 15th, 2012 at 1000 hours with the last logs on this date by TFC. Abbey #1314.
