VIDEO REPORT - SANDY HOOK ELEMENTARY SCHOOL

## ACTION TAKEN:

On Friday, 14 December 2012, I was assigned by Sergeant COVELLO, #0167, to produce a video recording during the processing of the scene of a multiple homicide investigation located at Sandy Hook Elementary School, 12 Dickenson Drive, Newtown, Connecticut.

A Cannon XL-1, color, digital video recorder and two Maxell, Mini DV, 60 minute color videotape cassettes and three Sony, Mini DV, 60 minute color videotape cassettes were used to produce the video recordings. The recordings were made using ambient and artificial lighting. A total of five video tapes were used to capture the scene and the inside of the Sandy Hook Elementary School.

The video commenced at approximately 1546 hours on 14 December 2012 and concluded on 20 December 2012 at approximately 2015 hours.

Videotape #1 of 5: Depicts footage of the scene and the surrounding conditions as found by members of the Western District Major Crime Squad upon their arrival. This videotape begins outside showing an overall view of the front of the school as well as the parking area. This video continues into the school capturing the entryway, hallway and classrooms containing victims.
