On the morning of May 11, 2013, I was contacted by Detective Daniel Sliby of the Western District Major Crime Squad - Litchfield, via phone, requesting me to assist him with an assignment. The assignment was to printout a department evidence label that he had prepared in the CAD/RMS. I was then placed the label onto a glass display table that had been secured at the Troop A garage and covered with a cloth. Det.
