**ACTION TAKEN**

On Friday, December 21, 2012, at approximately 1450 hours, I arrived at the Troop A Barracks in Southbury to escort the 2010 black Honda Civic, with CT Registration No. 872YEO (the "Subject Vehicle"), to the Troop L Barracks in Litchfield. The Subject Vehicle was being stored in a secured garage bay at Troop A. At approximately 1525 hours, Christopher Dinino, DOB [REDACTED], of Town Plot Auto Body, Inc., arrived at Troop A to transport the Subject Vehicle. Mr. Dinino loaded the Subject Vehicle onto the Town Plot Auto Body, Inc. flat bed wrecker bearing CT Commercial Registration No. K44498, and CT Wrecker Registration No. 8274. Mr. Dinino secured the Subject Vehicle to the bed of the wrecker and at approximately 1535 hours he began to drive to Troop L under my escort. At approximately 1615 hours, I arrived at Troop L with Mr. Dinino and the Subject Vehicle. Mr. Dinino unloaded the Subject Vehicle into the Troop L impound lot where it was secured behind a locked gate.

At no time did either Mr. Dinino or I enter the interior of the Subject Vehicle as Mr. Dinino was able to pull the Subject Vehicle both on and off the flat bed wrecker using cables attached to the undercarriage. Wrecker and Operator information, as well as the starting and ending mileage data, were entered into a separate Administrative Services incident under CFS# 1200717707.
