


(Clothing)

Beginning on Monday December 17th, 2012 and concluding on Tuesday December 18th, 2012 Detectives from the Western District Major Crime Squad (WDMCS), were tasked with the processing of the clothing items worn by the "Victim's" of the "Mass Murder/Shooting", located at the Sandy Hook Elementary School, #12 Dickinson Drive in the Town of Sandy Hook (Newtown), Connecticut. This Detective was assigned to take digital images as a standard procedural function during the processing of the clothing items.

The digital camera utilized was a Nikon D300 with a Nikon SB900 synchronized strobe flash unit where necessary.

The original images were copied from the compact flash card in the camera onto a compact disc for archival storage by the CSP Forensic Laboratory, Photography Section. See the attached compact discs for the images referenced in this report.






