
PHOTOGRAPH REPORT

On Thursday January 17th, 2013 Detectives from the Western District Major Crime Squad (WDMCS), were tasked with the processing of the clothing items (**Exhibit #83**), worn by Adam Lanza, "the shooter", (dob-04/22/1992) {OCME #12-17618}, as part of the on-going "Mass Murder/Shooting" investigation, located at the Sandy Hook Elementary School, #12 Dickinson Drive in the Town of Sandy Hook (Newtown), Connecticut. This Detective was assigned to take digital images as a standard procedural function during the processing of the clothing items. The clothing items were marked as **Exhibit #83(B) through Exhibit #83(P); with Exhibit #83(A)**, being postmortem fingerprints, which were not photographed for this report.

The digital camera utilized was a Nikon D300 with a Nikon SB900 synchronized strobe flash unit where necessary.





