**SCENE / EVIDENCE**

**ACTION TAKEN:**

Beginning on Friday December 14, 2012 at approximately 1722hrs and concluding on Thursday December 20, 2012, a series of photographs were taken during the processing of the scene of a school shooting at the Sandy Hook Elementary School, located at 12 Dickenson Drive in the Town of Newtown CT. The investigation into this shooting was being conducted by the Connecticut State Police in conjunction with the Newtown Police Department and Federal Bureau of Investigation. Various additional local, state, and federal agencies assisted. These photographs were taken as back up to the primary photographs taken by Detective Walkley #589.

A total of one thousand, three hundred, and forty four (1,344) images were taken utilizing my departmentally issued Nikon digital SLR D300 programmable camera with attached Nikon Speed Light SB-910 electronic flash, utilized when needed. A Verbatim 4GB Compact flash card was used to store the images until they could be burned to a DVD-R in their original form. Original images are stored and remain on file at the CSP-Photo lab in Meriden CT.
