Mr. Sedensky indicated that no further investigation is needed into the incident (Refer to attached email message).

A letter will be sent from his office to the Eastern District Major Crime Squad indicating that the investigation is formally closed.

Based on the above stated information the investigation will now be closed with no further action anticipated.

CASE STATUS:

The investigation is now closed with no criminal prosecution.
