VIDEO REPORT

Action Taken: On 12-14-12, starting at approximately 1924hrs., a Crime Scene Video was produced by this writer during the investigation of a Murder, which occurred inside 36 Yogananda St., Sandy Hook (Newtown), Connecticut.

On 12-14-12, The Newtown Police Department, along with Troopers from Troop A in Southbury responded to the school shooting at the Sandy Hook School in Newtown (CFS12-00704559). As a result of that investigation, ESU responded to the suspects (ADAM LANZA) residence at 36 Yogananda St., in Sandy Hook where Lanza's mother Nancy Lanza, was found deceased. The Connecticut State Police – Eastern District Major Crime Squad was requested and assigned the investigation at 36 Yogananda St., in Sandy Hook, CT.

The scene video shows the location of the of the residence at 36 Yogananda St., to include the exterior and surrounding area, as well as the entire interior of the residence to include the second floor master bedroom where the deceased was located. The video was taken on 12-14-12, beginning at approximately 1924hrs., by Detective Jeffrey Payette #679 using a Sony HDR-CX110 digital video camera, and a Verbatim 8gb SDHC Premium SDHC card. An original copy of the video was transferred to a Verbatim DVD-R utilizing a Sony DVD Direct VRD-MC3 DVD recorder and is being stored at Eastern District Headquarters in Norwich, CT. A copy of the original recording was made utilizing a Systor Pro-duplicator, and is attached to this report. The video was recorded under the authority of a search warrant completed on 12-14-12 by members of the Connecticut State Police – Central District Major Crime Squad.
