BACKUP DIGITAL IMAGE REPORT

ACTION TAKEN: On Friday December 14th, 2012 at approximately 0941 hours, Connecticut State Police Personnel responded to an active shooter at the Sandy Hook Elementary School located at #12 Dickenson Drive in Newtown, Connecticut.

(Refer to Companion Case Number CFS12-00704559 for Details)

On Friday December 14th, 2012, Connecticut State Police Emergency Service Unit (ESU) members went to the residence of Adam Lanza (w/m d.o.b 04/22/1992), who was the Suspect for the school shooting. Adam's residence was at #36 Yogananda Street in the Sandy Hook section of the town of Newtown, Connecticut. ESU members made forced entry into the residence and located a deceased female inside the residence in a bedroom on the second floor, suffering with what appeared to be a gunshot wound to the head. The female Victim at #36 Yogananda Street Sandy Hook, CT., was identified as Adam Lanza's Mother, Nancy Lanza (w/f d.o.b 09/06/1960).

On Friday December 14th, 2012 at approximately 1510 hours, Eastern District Major Crime Squad (EDMCS) Detectives were assigned to investigate the homicide of Nancy Lanza (d.o.b 09/06/1960), at #36 Yogananda Street in Sandy Hook, Connecticut. EDMCS Detectives responded to #36 Yogananda Street and processed the scene.

Upon my arrival at the scene located at #36 Yogananda Street Sandy Hook, CT., I was assigned by my Supervisor, Sergeant John F. Turner #0245, to capture backup digital photographs of the scene. EDMCS Detectives processed and searched the residence/scene at #36 Yogananda Street from Friday 12/14/2012 until Monday 12/17/2012.

On Friday December 14th, 2012, between approximately 2038 hours to Saturday December 15th, 2012 at approximately 0754 hours I took the below described digital color images #1-667. The photos were taken as part of the investigation of the homicide. The images depict the interior and exterior scene to include evidence items, and other contents, located at #36 Yogananda Street in the Sandy Hook section of the town of Newtown, CT. The photographs are a true and accurate depiction of the scene and items at the time of photography. (Refer to Evidence Report and Sketch Map for Details on Specific Items Seized)

The images were taken by me, (Detective Ryan E. Luther #0702), of the Connecticut State Police Eastern District Major Crime Squad in Norwich, CT. The images were taken utilizing a Nikon D300 digital camera with electronic flash and stored on a Verbatim 8GB SD card. The images were subsequently transferred to a "Memorex" DVD-R disc which is being stored at the Connecticut State Police Eastern District Major Crime Squad Headquarters located at #401 W. Thames Street Unit #500 Norwich, CT.

ESU members made forced entry into the residence and located a deceased female inside the residence in a bedroom on the second floor, suffering with what appeared to be a gunshot wound to the head. The female Victim at #36 Yogananda Street Sandy Hook, CT., was identified as Adam Lanza's Mother, Nancy Lanza (w/f d.o.b 09/06/1960).

On Friday December 14th, 2012 at approximately 1510 hours, Eastern District Major Crime Squad (EDMCS) Detectives were assigned to investigate the homicide of Nancy Lanza (d.o.b 09/06/1960), at #36 Yogananda Street in Sandy Hook, Connecticut. EDMCS Detectives responded to #36 Yogananda Street and processed the scene.

Upon my arrival at the scene located at #36 Yogananda Street Sandy Hook, CT., I was assigned hy my Supervisor, Sergeant John F. Turner #0245, to capture backup digital photographs of the scene. EDMCS Detectives processed and searched the residence/scene at #36 Yogananda Street from Friday 12/14/2012 until Monday 12/17/2012.

On Monday 12/17/2012 between approximately 0045 hours to 0055 hours, I took the attached Twenty (20), backup digital color images as part of the investigation. The images depict the interior and exterior of the residence/scene, located at #36 Yogananda Street in the Sandy Hook section of the town of Newtown, Connecticut.
