


On 12/15/12 at approximately 0225 hours the attached twenty-seven (27) digital color photographs were taken in connection with a homicide investigation being conducted by the Connecticut State Police Eastern District Major Crime Squad at 36 Yogananda Street in Sandy Hook, CT.



All of the photographs were taken at 36 Yogananda Street, the residence of Nancy and Adam Lanza while conducting a Body Survey on Nancy Lanza in her master bedroom.

The photographs were taken by Detective Priscilla Vining #343 of the Eastern District Major Crime Squad in Norwich, CT with a Nikon D300 digital camera and flash card. The photos were later transferred from the flash card to a Maxell CD-R disc and further copies were made.

One copy is being stored at the office of the Eastern District Major Crime Unit, 401 W. Thames Street Norwich, Connecticut. Three other copies will be disseminated along with the case book for this investigation as follows: (1) copy to the Western District Major Crime Unit; (1) copy to the Danbury State's Attorney's Office and (1) copy to the Connecticut State Police Reports and Records Unit Connecticut.
